

## **Istituto Marangoni Scholarship Campaign**

**Istituto Marangoni Dubai** offers best talents the opportunity to benefit from a deduction as a facilitation to the enrollment in its courses. Scholarships are intended as a deduction on the tuition fees (enrolment fee is always due).

This Regulation refers to the Scholarship Campaign dedicated to Courses starting in the September & October 2023 intake.

### **Deduction opportunities**

Students can apply for up to AED 20.000 deduction on the tuition fee on long courses and up to AED 3,000 on professional courses (please, note that the enrolment fee is always due). The deduction can be applied to Courses at Undergraduate, Postgraduate & Preparatory level offered by Istituto Marangoni at the following schools:

For those applying to three-year courses: any deduction awarded is applied only to the first year of the three years of study.

Multiple requests shall not be considered. Participation in the selection is free of charge.

No extra costs will be charged other than those deriving from the candidate's internet network connection for accessing the service, which are the responsibility of the user.

Istituto Marangoni assumes no responsibility for events beyond its reasonable control including, without limitation: the access, bar to access, the malfunction and difficulties relating to the technical instruments, the software and the hardware, the transmission and the connection, the data which can bar the candidate from participating in the selection. A mandatory requisite for the participation in this selection is the candidates' explicit consent to the processing of his/her personal data.

### **Selection and Assignment Criteria**

The Istituto Marangoni Scholarship Committee will select the winners based on the materials provided by the candidate. Materials submitted may not contain images and/or contents which are or could be considered offensive, illegal and/or immoral, nor sexually suggestive materials which promote, also potentially, offensive, profane, violent, obscene, or hate speech based upon the race and/or sex of an individual or group. The rights of use for iconographic materials are considered property of the Candidate.

All accompanying texts and documents submitted shall be written in English. Content in any other language will not be made visible. Istituto Marangoni reserves the right to exclude from participation candidates who submit materials which do not comply with the Regulation.

Candidates interested in courses at Undergraduate and Preparatory level, starting in the September 2023 intake, shall upload the requested materials and finalize the application from June 1<sup>st</sup> 2023 to July 31<sup>st</sup> 2023.

Application deadlines for any eventual special project will be specified in a dedicated regulation.

Candidates will receive a confirmation e-mail for the application submitted. If candidates do not receive the confirmation email, are invited to contact [scholarships@istitutomarangoni.com](mailto:scholarships@istitutomarangoni.com) no later than 24 hours after submission. Applications are evaluated on a rolling basis. Applicants will be notified regarding the outcome of their application once the Committee has come to a final decision.

### **Terms of Assignment and Acceptance**

Please note that all applications received will be evaluated on a rolling basis. Awarded candidates will be asked to confirm the acceptance of the offered deduction within 3 working days and to pay the due enrolment fee within one week from the acceptance day. Lacking a feedback and the payment of the enrolment fee from the applicant side, awarded candidate name will be removed from the list of recipients and a place shall not be guaranteed after this time. By accepting the deduction and enrolling into an Istituto Marangoni programme, the candidate implicitly accepts to become an Istituto Marangoni Scholarship testimonial for the following Campaigns, where requested. The regular attendance of the course as well as the maximum commitment on the part of the deduction recipient will be a binding requisite to obtain the final certificate. The possible decision on the part of the participant to postpone their participation to the Course will automatically lead to the cancellation of the deduction assigned. In case the selected Istituto Marangoni course is not activated for the February 2024 intake at the School of interest, the applicant may be offered to use the deduction to enroll into the same course in another Istituto Marangoni School. Alternatively, the applicant may be offered a similar course at the same School.

### **Jury**

The Scholarship Committee is composed by Istituto Marangoni leading Faculty members. The Scholarship Committee will unquestionably judge and select the most appropriate candidate profiles.

### **Required documents for Foundation Courses**

In order to request a Scholarship for a Foundation course, students are asked to provide:

- Personal statement
- Copy of high school diploma and school certificates\* (Students who haven't completed high school can submit predicted grades)
- Copy of passport / ID

### **Required documents for Three-Year and Undergraduate Progression Courses\***

In order to request a Scholarship for an Undergraduate course, students are asked to provide:

- Personal Statement
- Copy of high school diploma and school certificates (Students who haven't completed high school can submit predicted grades)
- Copy of passport / ID
- For the Fashion Styling program, Interior Design, Visual Design and Fashion Design & Accessories, Product Design: 6 creative ideas\*\*
- For the Fashion Business program: written piece of work\*\*\*

\* Students applying to the three-year programs must have at least 13 years of secondary education

\*\* 6 self-produced Creative Ideas can be anything that visually describes their inspiration and the area of study that they have chosen. They can be submitted in the form of sketches, drawings, photographs, moodboards and collages. The 6 creative ideas might also be a mix of these. They can also be a personal reinterpretation of objects, environments, people, situations, etc. or design ideas such as a representation of personal creations such as outfits/fashion collections, objects, furniture pieces, interior spaces, etc. according to the desired program you are applying to. All items must be submitted in A4 or A3 format, in .pdf, .tiff, .jpg, .zip.

\*\*\* The document should include a critical reflection on a contemporary phenomenon relevant for the fashion industry (e.g. sustainability, inclusivity, digitalization etc.) or the analysis of a brand of their choice. The text should be accompanied by visual research and a list of references and be submitted as a pdf file.

#### **Required documents for One Year intensive Courses:**

- Personal statement
- Copy of passport / ID
- Copy of high school diploma (and university certificates if available)

#### **Required documents for Master Courses:**

- Personal statement letter
- Bachelor's degree certificate
- University transcripts
- Creative portfolio: The portfolio must demonstrate the student's creative and technical skills. The portfolio must include 10-12 illustrations, photos and/or slides and a brief description on the project development;
- Two reference letters: from teachers or past employers;
- Copy of passport
- Curriculum vitae;

#### **Required documents for Professional Courses:**

- Copy of passport / ID
- Personal Statement
- Curriculum Vitae

Please be aware that to enroll in the Dubai Courses there are language requirements to be attested upon obtaining the scholarship as they will be mandatory for enrolment. In detail:

- For all Three-Year and Undergraduate Progression Courses: non English native speakers must provide a certificate of language skills, level B1 of CEFR with specific requirements
- For the Master Courses: EMSAT 1400/IELTS 6.0/TOEFL ITP 550/ TOEFL IBT 79/PTE Academic 52/ The Cambridge English: Advanced Test of English 50
- Professional Programme and One Year courses: It is envisaged to have a minimum language knowledge equal to b1 CEFR1 level.
