1. Contest Object

2. How to Participate

To participate, you need to prepare and upload the following documents based on the course of interest:

- Fashion Styling & Multimedia Intensive (One-Year Intensive)
- Letter of motivation
- Copy of the high school diploma (or a copy of the equivalent degree or diploma for the One-Year Intensive course)
- Copy of the grade certificate
- Copy of an identification document
- For three-year courses and non-native speakers: a language certificate at least equivalent to level B1 of the Common European Framework of Reference for Languages (CEFR), according to specific requirements (e.g., for English: IELTS 4.5, with no subscores below 4.0)

Postgraduate Course:

- Fashion Styling, Creative Direction & Digital Content (Master)

- Letter of motivation
- Curriculum Vitae
- 2 letters of reference
- Transcript of grades
- Copy of the degree certificate or equivalent diploma (if the degree certificate has not yet been obtained, the transcript of grades is sufficient)

- For non-native speakers: a language certificate at least equivalent to level B2 of the Common European Framework of Reference for Languages (CEFR), e.g., for English: IELTS 5.5

4. Jury

A selection committee composed of representatives from Istituto Marangoni Firenze and the editorial team of I'M Firenze Digest will evaluate all applications. The winners will participate in the editing of I'M Digest.

5. Award

Available for candidates are scholarships for the three-year, Master, and One-Year courses in Fashion Styling starting at Istituto Marangoni Firenze • The School of Fashion & Art in the academic year 2023/2024. Scholarships consist of a reduction in the tuition fees for the selected course, up to a maximum of 50% on the tuition fees (valid only for the first year for three-year programs) offered by Istituto Marangoni Firenze • The School of Fashion & Art in reference to the academic year 2023/24 (September 2023). The scholarship obtained is valid only for the selected course starting in September 2023 and is not transferable to subsequent intakes (January 2024).

6. Results and Publication

At the end of the selection process conducted by the jury, the winners of the competition will be notified via email or by phone. The selected participant for the scholarship must confirm their interest within 3 working days from the date of the first email communication. If this period passes without any communication from the winner, the offer will be considered forfeited, and the scholarship will be reassigned. Acceptance of the scholarship implies an obligation for the winner to apply for the selected course and pay the remaining portion of the enrollment and tuition fees.

7. Rights and Use of Submitted Productions

Participants (hereinafter referred to as "participants") agree to transfer to Instituto Marangoni S.r.I., Via Verri 4, Milan (Tax Code 09447270159) (hereinafter referred to as "Instituto Marangoni") the right to use creative projects (hereinafter referred to as the "project") and products that, where possible, will be implemented as a result of the project, the right to use any production delivered for participation in the "I'M FIRENZE DIGEST" ideas competition, as well as all materials related to projects and delivered, including graphic designs of the project, texts, video materials, and photos.
