# ISTITUTO MARANGONI 90<sup>th</sup> ANNIVERSARY SCHOLARSHIP

Istituto Marangoni offers students the opportunity to benefit from a deduction as a facilitation to the enrollment in its courses at the three Italian schools: Milano, Milano Design and Firenze. Scholarships are intended as a deduction on the tuition fees (enrolment fee is always due). This Regulation refers to the 90<sup>th</sup> Anniversary Scholarship dedicated to courses starting in the September 2025 intake for:

- Istituto Marangoni Milano
- Istituto Marangoni Milano Design
- Istituto Marangoni Firenze

#### 1. Award and Available courses

Participants will be able to apply for

- A deduction up to € 15.000 (€ 5.000 per each academic year) on the tuition fee of the 3-year undergraduate courses;
- A deduction up to € 10.000 on the tuition fee for Foundation, One Year, Master and Master of Arts courses (enrolment fee is always due);

The deduction can be applied to courses at Undergraduate and Postgraduate level offered by Istituto Marangoni Milano, Milano Design and Firenze. For 2-year Master of Arts courses, please note that the deduction will only be applied to the tuition fee of the first year. Please note that the deduction granted for Three-Year and BA (Hons) programmes are only valid for the first year of the three years of study.

\* Students who successfully complete the Foundation and One year Intensive programmes will be awarded with an Istituto Marangoni certificate.

\*\* Participants who comply with the Ministerial Requirements and successfully complete Three-Year Courses in Milano, Milano Design or Firenze will be awarded with a First Level Academic Diploma. Recognised by MUR (Italian Ministry of University and Research) as an academic diploma equivalent to a University Undergraduate BA Degree, participants will obtain 180 CFA (Crediti Formativi Accademici) equivalent to 180 ECTS credits. \*\*\*Students who instead do not comply with the Ministerial Requirements and complete the Three year courses will be awarded with an Istituto Marangoni private certificate.

Master of Arts (2-years) courses\*\*\*\*\*\*

\*\*\*\* Participants who comply with the Ministerial requirements and successfully complete the Master Degree Courses in Milano, Milano Design or Firenze will be awarded with a First Level Academic Master Diploma. Recognized by the Italian Ministry of University and Research as an Academic Diploma equivalent to a University Postgraduate Master Degree, participants will obtain 60 ECTS credits.

\*\*\*\*\*Students who instead do not comply with the Ministerial requirements will be awarded with an Istituto Marangoni private Master certificate.

\*\*\*\*\*\* Participants who comply with the Ministerial requirements and successfully complete the Master of Arts courses in Milano, Milano Design or Firenze will be awarded with a Second Level Academic Diploma. Recognized by the Italian Ministry of University and Research as an Academic Diploma equivalent to a Master of Arts Degree, participants will obtain 120 CFA (Crediti Formativi Accademici) equivalent to 120 ECTS credits.

#### 2. How to apply

In order to submit the application, candidates will need to:

- Go the dedicated web page (https://www.istitutomarangoni.com/en/admission/scholarships)
- Fill out all fields with their personal data;
- Select the school/programme they wish to apply for;
- Submit all the required documents;
- Read and accept the privacy terms and conditions;
- Click on submit.

Candidates will receive a confirmation e-mail for the application submitted. If candidates do not receive the confirmation email, are invited to contact

scholarships@istitutomarangoni.com no later than 24 hours after submission.

Applications are evaluated on a rolling basis.

Each candidate can submit only one application for a designated School.

Participation in the selection is free of charge.

No extra costs will be charged other than those deriving from the candidate's internet network connection for accessing the service, which are the responsibility of the user. Istituto Marangoni assumes no responsibility for events beyond its reasonable control including, without limitation: the access, bar to access, the malfunction and difficulties relating to the technical instruments, the software and the hardware, the transmission and the connection, the data which can bar the candidate from participating in the selection. A mandatory requisite for the participation in this selection is the candidates' explicit consent to the processing of his/her personal data.

#### 3. Required documents

- Copy/scan of passport;
- Signed personal statement indicating your motivation for the request.

The documents required to apply for a deduction for **Undergraduate Courses**  $\cdot$  **Three-Year\*, BA (Hons) courses a**re:

- Copy/scan of High School Diploma/Grades certificates;
- Copy/scan of passport;
- Signed personal statement indicating your motivation for the request;
- 6 Creative ideas (only for creative courses\*\*;
- Piece of written work (only for business courses)\*\*\*;

\*\* Applicants for creative courses are requested to submit 6 self-produced creative ideas: these can be anything that visually describes their inspiration and the area of study that they have chosen. They can be submitted in the form of sketches, drawings, photographs, mood-boards and collages (the 6 creative ideas might also be a mix of these). They can also be:

- Personal reinterpretations of objects, environments, people, situations, etc...
- Design ideas: representations of personal creations such as outfits/fashion collections, objects, furniture pieces, interior spaces, etc. (according to the desired course you are applying to). all items must be submitted in A4 or A3 format, in .pdf,.tiff, .jpg, .zip.

\*\*\* Applicants for business courses are requested to submit a 500 word document about one emerging trend. The document should include a critical reflection on a contemporary phenomenon relevant for the fashion industry (e.g. sustainability, inclusivity, digitalization etc.) or the analysis of a brand of their choice. The text should be accompanied by visual research and a list of references and be submitted as a .pdf file.

The documents required to apply for a deduction for **Master Courses, Master's Degree courses and Master of Arts** are:

- Copy/scan of passport;
- Signed personal statement indicating your motivation for the request;
- Curriculum Vitae;
- 2 Reference letters;
- Copy of University Degree certificate;
- Copy of Grade Transcript;
- Portfolio (only for creative courses)\*\*;

\*\* For creative Master's Courses, submit a portfolio of 10-12 drawings, photographs and/or slides. The portfolio must demonstrate your creative abilities and technical skills, supported by a brief description of your personal contribution to the development the project.



#### 4. Selection and Assignment Criteria

The Istituto Marangoni Scholarship Committee will select the winners based on the materials provided by the candidate. Materials submitted may not contain images and/or contents which are or could be considered offensive, illegal and/or immoral, nor sexually suggestive materials which promote, also potentially, offensive, profane, violent, obscene, or hate speech based upon the race and/or sex of an individual or group. The rights of use for iconographic materials are considered property of the Candidate. All accompanying texts and documents submitted shall be written in English. Content in any other language will not be made visible. Istituto Marangoni reserves the right to exclude from participation candidates who submit materials which do not comply with the Regulation.

#### 5. Calendar

Candidates interested in courses starting in the September 2025 intake, shall upload the requested materials and finalize the application no later than September 8<sup>th</sup>, 2025 Applicants will be notified regarding the outcome of their application once the Committee has come to a final decision.

#### 6. Results and Publication

Please note that all applications received will be evaluated on a rolling basis. Awarded candidates will be asked to confirm the acceptance of the offered deduction within 3 working days and to pay the due enrolment fee within 5 working days from the acceptance day.

Lacking feedback and the payment of the enrolment fee from the applicant's side, the awarded candidate will be removed from the list of recipients and the scholarship shall be considered as expired and shall be reassigned.

By accepting the deduction and enrolling into an Istituto Marangoni programme, the candidate implicitly accepts to become an Istituto Marangoni Scholarship testimonial for the following Campaigns, where requested.

The regular attendance of the course as well as the maximum commitment on the part of the deduction recipient will be a binding requisite to obtain the final certificate. In case the selected Istituto Marangoni course is not activated for the September 2025 intake at the School of interest, the applicant may be offered to use the deduction to enroll into the same course in another Istituto Marangoni School. Alternatively, the applicant may be offered a similar course at the same School.

Any scholarship allocated to the intake for which the student is enrolling (e.g. September '25) will NOT be automatically valid and confirmed for the next intake (e.g. January '26). The Academic Committee will assess any reassignment.



#### 7. Academic Committee

The Scholarship Committee is composed by Istituto Marangoni leading Faculty members. The Scholarship Committee will unquestionably judge and select the most appropriate candidate profiles.

#### 8. Property rights

The candidate assures that all intellectual property rights used in the material provided are owned by the candidate or the candidate has a consent to use materials, texts or images of third parties.

The candidate will keep Istituto Marangoni exempt, without limitation, from any claim, liability, costs, expenses, damages, injuries, direct and indirect losses, loss of business, that may raise to Istituto Marangoni as a consequence of direct or indirect use of third-party materials, texts or images. Candidates agree to allow Istituto Marangoni to use, severally or jointly, texts and images of their own dream; property rights of all images and texts shall be exclusively and definitively transferred to Istituto Marangoni, free of charge and without time limitation.

- (iii) that the Project shall not contain any obscene, violent, defamatory, blaspheme, upsetting elements and that the it shall not infringe any third party personal and patrimonial right (including moral rights, image rights, honour and/or reputation and/or confidentiality rights, copyrights, data protection, publishing and/or others rights) or any applicable law;
- (iv) In the event that the Project contains elements and/or parts of works of third parties, Participant warrants that it has obtained in advance and/or obtains all necessary consents, releases and/or authorizations, as well as all rights to use the Project granted herein;
- (v) that there are no rights or agreements with third parties that would interfere with the rights granted herein and with the full and free use and arrangement of the Project by Istituto Marangoni and its successors.

In any case, the Participant undertakes to indemnify and hold Istituto Marangoni and its successors harmless with respect to every demand, claim, contestation or request, whether made or brought before the courts or otherwise, by third parties related to the Project and/or to the rights granted pursuant the article 9 and/or that are inconsistent with the representations, warranties and obligations that the Participant has provided herein or by law and/or may interfere with the full and free exploitation by Istituto Marangoni and its successors of the rights granted herein.

## 10. Information notice on personal data processing

Personal data ("Data") collected in relation to participation in the Initiative will be registered in the database of Istituto Marangoni, controller of the treatment ("Data Controller"), pursuant to of the General European Data Protection Regulation (Regulation (EU) 2016/679 of the European Parliament and of the Council, of 27 April 2016 and related implementing legislation (hereinafter, jointly, the "Regulation").

Data of the Participants collected in relation to their participation in the Initiative will be processed by Data Controller for the following purposes: .

(i) to enable Participants to submit their application and, if necessary, to subsequently provide further information useful and/or necessary for the assessment of their application;

(ii) for purposes related with and instrumental to the process of evaluating, reviewing and selecting of the validly submitted applications;

(iii) for the management of the participation in the Initiative, including sending requests for integration of the application, information materials, updates, communications and/or changes to the programme related to the Initiative itself; as well as for deciding and announcing winners;

(iv) to fulfil any obligation provided for by laws, regulations, Community rules, orders, prescriptions and/or requests made by the Judicial Authority or by any person authorised to do so under legal provisions and secondary legislation;

(v) to exercise the rights and protect the legitimate interests of the Data Controller, such as the right the right to legal defence.

The processing of the Data for the purposes indicated in points (i), (ii) and (iii) above shall be carried out by Data Controller for the purpose of execute Participants' application, for the assessment and possible selection of the projects and - in the event of effective selection and confirmation - for announcing and proclaiming the winners and therefore does not require Participants' express consent (pursuant to article 6.1 letter (b) of the Regulations). For such uses, the release of the data requested by Istituto Marangoni is indispensable and, therefore, failure to provide such Data will prevent Participants' application from being examined and, consequently, their participation in the Initiative (pursuant to article 6.1, letter (b) of the GDPR).

Data processing for the purposes specified in points (iv) and (v) above is carried out to fulfil legal obligations, and therefore does not require Participants' express consent (pursuant to article 6.1, letter (c) of the GDPR).

Participants' Data shall be processed by means of manual, computer and electronic tools, in any case able to guarantee the security thereof and to avoid unauthorised access to the Data.

Participants' Data and projects shall be communicated by Istituto Marangoni to third parties for the purposes of selecting and evaluating Projects within the scope of the Initiative. The release of Data for this purpose is necessary to participate in the Initiative.

Pursuant to the Regulation, those whose Data are collected as a result of the participation in the Initiative are entitled to: a) obtain information on the existence of the data and the purpose for which the Data is processed, the storage period and the persons to whom the Data is disclosed; b) obtain disclosure of the Data in a format in common use, readable by any automatic, interoperable device; c) object to some or all of the processing; d) obtain the update, correction, integration, limitation, deletion, blocking or transformation of the Data to an anonymous form. Istituto Marangoni also reminds that Participants are entitled to contact the Data Protection Authority ((Piazza di Monte Citorio, 121 – 00186 Rome RM) to assert Participants' rights regarding the processing of the Data.

## 11. Use of personal data

Participants authorise Istituto Marangoni to use their Data and images, as well as to realise and acquire videos, photos, registrations and to consign their image through third parties and by any means and activity related to the Initiative within six months starting from the expiry of the Initiative.

## 12. Applicable law and jurisdiction

The Italian law will govern the Initiative and the relations between the Participants. Any dispute that may arise between the promoters and the Participants will be of exclusive jurisdiction of the Court of Milan (Italy).

Pursuant to the article 6, D.P.R. 430, dated 26/10/2001, this Initiative is not a prize competition or lottery: as a result, no ministerial authorization is needed.
